Participant Rules & Regulations

Garage Sale Operation

1. The Garage Sale will be held on Saturday April 27 from 8:00 am – 4:00 pm in the Cypress Centre.
2. Participants may set up Friday April 26 from 5 – 7 pm or Saturday morning between 6 – 7:30 am.
3. **Please note: You must sign a waiver if leaving your items overnight as we will not be responsible for anything that goes missing.**
4. All registration fees must be paid in full at the time of registration. (Cash, Debit, Visa, MasterCard, or Cheque) There is an NSF fee of \$40.00 on returned cheques.
5. Any cancellations after April 6 will result in the participant forfeiting his/her registration fee and space.
6. Participants causing damage to tables, chairs, walls, or the building in general, will be financially responsible for the repairs or replacement of the damaged items.
7. Tables will be set up by the Medicine Hat Exhibition & Stampede. Participants are responsible to maintain their area around the table in a clean and sanitary manner.
8. There will be no packing up or moving out early.

Responsibilities of the Medicine Hat Exhibition & Stampede

1. The Garage Sale Co-ordinator shall determine where each table is placed and shall have the authority to change the floor plan if deemed necessary.
2. Any person or participant may be removed from the Garage Sale by the Co-ordinator where, in the opinion of the Co-ordinator the conduct of that person threatens the safety or integrity of the Garage Sale as a whole or of any person therein with the use and/or enjoyment of the Garage Sale by any other person.
3. The Medicine Hat Exhibition & Stampede is not responsible for any liability arising out of the negligence of a participant or their employees for any injuries sustained by the employee of a participant.
4. The Medicine Hat Exhibition & Stampede will not be responsible for items broken, stolen, etc.
5. Any items not in the Garage Sale standards, as determined by the Co-ordinator will be removed.

Responsibilities of the Vendors

1. It is the responsibility of each participant to guarantee their items and release the correct information about the item.
2. Each participant is responsible for his/her own insurance for fire, theft, vandalism, etc.
3. Participants will behave in a courteous, professional, and respectful manner.
4. All participants are responsible to bring their own cash float.
5. No smoking or vaping in the building.
6. No hazardous items are to be sold. Ex: Paint, gas, solvent, etc.
7. No alcoholic beverages or drug paraphernalia allowed in the building.
8. No outside food or beverages are allowed in the building. The concession will be open during the Garage Sale hours.
